Challenges ahead: EU Green Deal & FitFor55 framework (1)

- EU Green Deal: make Europe the first climate-neutral continent by 2050.
- FitFor55 package: reach the goal of reducing net greenhouse gas (GHG) emissions by at least 55% by 2030.
- RED revision: 42.5% renewable energy share with an aspiration to reach 45% by 2030.
- EED revision: final energy consumption reduction of 11.7% by 2030 (based on 2020 levels), stepwise increasing annual energy savings to 1.9% from 2028 onwards (average of 1.49% of new annual savings for the period from 2024-2030), extending the annual 3% buildings renovation obligation to all levels of public administration.

Challenges ahead: EU Green Deal & FitFor55 framework (2)

- **EPBD revision:** aiming to contribute to reaching the target of at least **60% GHG emission reductions by 2030** in the building sector in comparison to 2015 and achieve **climate neutrality by 2050**.
- Buildings: 40% of EU's energy consumption, 36% of energy related GHG emissions, heating, cooling and domestic hot water account for 80% of the energy consumption by citizens. Roughly 35% of buildings over 50 years old, almost 75% energy inefficient, only about 1% renovation rate.
- Obligation to promote local heating and cooling plans in large municipalities having populations above 45.000.



Call to action: Cities & towns at the frontline (1)


- Cities and towns, with 75% of population of which 70% in cities and towns below 100.000 inhabitants, are always at the frontline of events: during the COVID crisis, the energy crisis and not least the ongoing and accelerating climate change affecting cities and towns.
- And while cities and towns are responsible for the biggest share of GHG emissions, they are also motors for change and job creation.
- The Covenant of Mayors signatory cities are frontrunning the journey to climateneutrality with their Sustainable Energy and Climate Action Plans.
- The **Covenant of Mayors** is part of a **wide range of EU-level initiatives**, only a few of which are introduced here.

Call to action: Cities & towns at the frontline (2)

- Support needed for the implementation: lack of capacity and skilled staff, while suffering from complex application processes, confusion over existing funds and being confronted with regulatory and legislative constraints.
- EU, regional and national funding alone is not sufficient, we need to mobilise private investment!
- EU City Facility and Smart Cities Marketplace facilitate the preparation of viable investment plans and matching them with private investment: so far approx. 130 projects equivalent with approx. EUR 715 million matched with investors' interest.
- Strong evidence that European cities and towns can tackle the challenge, being drivers for the European project and the EU Green Deal!



Covenant of Mayors in a nutshell



- World's largest movement of its kind
 - **11.000+ signatories**
 - **7.500+ action plans**, including
 - 2.000+ joint action plans
 - 200+ Covenant coordinators
 - 280+ Covenant supporters
- Political board
- Climate mitigation, climate adaptation and energy poverty
